WHY DO WE DO THIS?

-To focus on voter engagement of people with a criminal background.

- -To educate justice involved voters on their rights and eligibility to vote.
- -To increase the voter turnout from communities of color.
- -We want to help our communities better understand the issues and what's happening in our community.



CCJRC VRD/GOTV HIGHLIGHTS

2016: CCJRC registered over 300 people in the Denver jails through our JBV efforts.

- 2017: there was an off-year election. CCJRC did a GOTV push in Ward III in Aurora and helped increase the African American voter turnout. The African American Voter turnout was at an 18% which was a 2% increase in compared to other off year elections.
- 2018: CCJRC registered 790 people in the jails through our JBV efforts.
- CCJRC partnered with the SOS office to implement rule making7.4 that mandated all jails in each county to produce and have a voting plan/process put in place for voters in jails.
- 2019: CCJRC registered 34 people in the jails through our JBV efforts
- CCJRC defeated the ballot measure 1A- which stopped Arapahoe County from expanding and building a new jail.
- 2020: CCJRC conducted the first time ever polling stations in the jails and had about 200 people vote in person in the jails.

DETAILS MATTER!

There is a common misunderstanding that once a person has a criminal conviction s/he can never vote again. While this may be true in some states, it is NOT TRUE in Colorado!

On any given day, there are over 125,000 adults in Colorado who are currently involved in the criminal justice system. -MOST are eligible to vote.

Hundreds of thousands more have a past criminal conviction. ALL OF THEM are eligible to vote.

State Overview

Voting rights retained while in prison for a felony conviction in: Maine, Vermont, and the District of Columbia

Voting rights restored automatically upon release from prison in: <u>California, Colorado, Connecticut, Hawaii</u>, <u>Illinois, Indiana, Maryland, Massachusetts</u>, <u>Michigan, Montana, New Hampshire, New Jersey, New York, Nevada, North</u> <u>Dakota, Ohio, Oregon, Pennsylvania, Rhode Island, Utah</u>, and <u>Virginia</u>

Voting rights restored automatically upon completion of sentence, including prison, and both parole, and probation

in: <u>Georgia</u>, <u>Idaho</u>, <u>Iowa</u>, <u>Kansas</u>, <u>Louisiana</u>, <u>Minnesota</u>, <u>Missouri</u>, <u>Nebraska</u>, <u>New</u> <u>Mexico</u>, <u>North Carolina</u>, <u>Oklahoma</u>, <u>South Carolina</u>, <u>South</u> Dakota, Texas, Washington*, West Virginia, and Wisconsin.

Voting rights restoration can depend on the date or type of conviction, repayment of fines, the outcome of an individual petition to the government, or gubernatorial pardon

in: Alabama, Alaska, Arkansas, Arizona, Florida, Delaware, Kentucky, Mississippi, Tenn essee, and Wyoming.

COLORADO LAW


No person while serving a sentence of detention or confinement in a correctional facility, jail, or other location for a felony conviction is eligible to register to vote or to vote in any election. A confined prisoner who is awaiting trial but has not been tried or who is not serving a sentence for a felony conviction shall be certified by the institutional administrator, may register to vote pursuant to this article 2, and may list his or her confinement location as his or her ballot address in accordance with section 1-2-204(2) (f.3). An individual serving a sentence of parole is eligible to register to vote and to vote in any election.(5) A person confined in a state institution for persons with behavioral or mental health disorders shall not lose the right to vote because of the confinement



CCJRC PASSED A NEW LAW!

As of July 1, 2019, the laws on voter eligibility for people on Parole has changed! HB19-1266 permits people on parole who have completed their sentence of incarceration to register to vote and vote.

The new law effects approximately 10,000 people in our state.




THERE ARE REAL CONSEQUENCES IF YOU TELL PEOPLE THE WRONG INFORMATION!!!

If you inadvertently tell someone that they **are ineligible** to vote but they are **eligible** to vote, you are contributing to




WRONG Information contained If you inadvertently tell someone that they **are** eligible to vote but they aren't, you put them at risk of being criminally charged since it is a class 5 felony to register to vote or vote in Colorado if you are not eligible.



FREQUENTLY ASKED QUESTIONS

Will I get an official letter telling me when I am eligible?

A: No. No one will tell you when you're eligible to vote.

What If I was convicted for a crime in another state?

A: Voting eligibility is based on Colorado state law. It does not matter what state you were convicted in or whether you were convicted in municipal, state or federal court.

Do I have to pay off all my restitution before I can vote?

A: No. Payment of restitution is not a condition of voting eligibility.

I was registered to vote before incarceration. Do I need to register again?

- A: Yes. If you were registered to vote prior to your incarceration, there is a good chance that your name was removed from the Secretary of State's list of registered voters. You will need to re-register to vote.
- If someone is diverted to a halfway house by the courts, meaning they never went to prison, are they eligible to register to vote and vote.

A: Yes, they are eligible.

If someone is coming out of prison and they get sent to a halfway house, are they eligible?

A: No, they are not eligible because their inmate status is under DOC watch. Meaning they are still serving time whether it's in a residential or nonresidential community.
